PROPOSED OUTCOME:

- Denies application without prejudice.
- Closes the proceeding.

SAFETY CONSIDERATIONS:

- Balances the need for electric reliability and the need to reduce greenhouse gas through the Loading Order.

- There are no costs associated with the outcome of the proposed decision.

Item # 47a [13887] – PRESIDENT PICKER’S ALTERNATE TO ITEM 13794

A14-09-007 – Application of San Diego Gas & Electric Company for Authority to Partially Fill the Local Capacity Requirement Need Identified in D.14-03-004 and Enter into a Purchase Power Tolling Agreement with Carlsbad Energy Center, LLC.

Ratesetting

PROPOSED OUTCOME:

- Approves San Diego Gas & Electric Company’s (SDG&E) request for authority to enter into a purchase power tolling agreement with Carlsbad Energy Center, LLC subject to the following two conditions:
 - The project contract capacity is reduced from 600 megawatts (MWs) to 500 MWs while otherwise subject to the same per unit price and other terms and conditions as the agreement first presented in the application; and
 - All of the 100 MWs in residual procurement authority resulting from the amendment of the purchase power tolling agreement must consist of preferred resources or energy storage.

SAFETY CONSIDERATIONS:

- Approval of the purchase power tolling agreement will provide local reliability needs in SDG&E’s service territory and will assist with the integration of renewables resources in the state.

ESTIMATED COST:

- Actual costs of the power purchase tolling agreement are confidential at this time.





Regular Agenda – Communication Orders

Item # 49 [13783] – Denying Bright Fiber Network LLC's Application for a Certificate of Public Convenience and Necessity

A13-03-010 – In the Matter of the Application of Bright Fiber Network, LLC for a Certificate of Public Convenience and Necessity to Provide Full Facilities Based and Competitive Local Exchange Access and Interexchange Services within California and specifically, within Nevada County.

Ratesetting

Comr. Sandoval / Judge Colbert

PROPOSED OUTCOME:

- Denies Bright Fiber Network LLC a Certificate of Public Convenience and Necessity (CPCN).
- Closes the proceeding.

SAFETY CONSIDERATIONS:

- By not issuing a CPCN, the Commission avoids permitting a non-telephone company to operate without the ability to regulate it.

ESTIMATED COST:

- This decision denies the application and therefore there are no costs.





Regular Agenda – Communication Orders

Item # 49a [13785] – COMMISSIONER SANDOVAL'S ALTERNATE TO ITEM 13783

A13-03-010 – In the Matter of the Application of Bright Fiber Network, LLC for a Certificate of Public Convenience and Necessity to Provide Full Facilities Based and Competitive Local Exchange Access and Interexchange Services within California and specifically, within Nevada County.

Ratesetting

Comr. Sandoval

PROPOSED OUTCOME:

- Grants the application of Bright Fiber Network, LLC (Bright Fiber) for a Certificate of Public Convenience and Necessity (CPCN) for limited-facilities based local exchange and access services.
- Requires Bright Fiber to file tariffs with the Commission before it can offer local exchange services.
- Requires that Bright Fiber must receive additional authority from the Commission as part of its California Advanced Services Fund (CASF) grant application before it can perform any construction activities other than installation of equipment in existing buildings or structures.
- Closes the proceeding.

SAFETY CONSIDERATIONS:

- Holders of CPCNs are subject to Commission Orders, Rules, Decisions and Regulations, including those enforcing consumer protection, service quality, privacy, and providing reliable access to emergency services via 911.

ESTIMATED COST:

- No cost.





Regular Agenda – Water / Sewer Orders

Item # 50 [13920] – Orders Water Utility Compliance With the State Water Resources Control Board's Regulation Implementing Governor Brown's Executive Order, B-29-15, Issued April 1, 2015

Res W-5041

PROPOSED OUTCOME:

- On April 1, 2015, Governor Edmund Brown Jr. issued Executive Order B-29-15 ordering further reductions in potable water usage through February 28, 2016.
- The State Water Resources Control Board and the Commission are to impose restrictions on urban water suppliers and the investor-owned utilities to achieve a statewide 25% reduction in potable water usage.
- Both the State Board and the Commission are to develop rate structures and other pricing mechanisms to maximize water conservation to achieve the 25% reductions, along with monetary penalties – to the water agencies and water utilities – for failure to comply.
- The State Board anticipates adopting these new regulations on May 5/6, 2015 and the Commission is to follow suit.

SAFETY CONSIDERATIONS:

- The severe drought is putting Californians' water needs for basic health and safety at risk and issuing these new restrictions on the use of potable water is a key step in water conservation.

ESTIMATED COST:

- \$500,000 for all investor-owned utilities for direct mailings and notices to comply with Schedule 14.1 requirements.





Regular Agenda – Transportation / Rail Safety Orders

Item # 51 [13884] – Revising Procedures Regarding Processing Applications of Passenger Stage Corporations

R09-12-001 – Order Instituting Rulemaking to Examine Whether the Current Procedures for Processing Applications to Obtain or Transfer a Passenger Stage Corporation Certificate, to Acquire or Control a Passenger Stage Corporation, and to Establish a Zone of Rate Freedom Should be Revised.

Quasi-Legislative

Comr. Florio / Judge Colbert

PROPOSED OUTCOME:

- Revises procedures for: granting/denying applications for a passenger stage corporation (PSC) certificates; granting authority to transfer an existing PSC certificate; granting authority to acquire or control a PSC; and for establishing a zone of rate freedom (ZORF).
- Revises Rule 3.3 of the Commission's Rules of Practice and Procedure to conform to the changes.
- Closes the proceeding.

SAFETY CONSIDERATIONS:

- The proposed revisions simplify the Commission's regulatory procedures regarding PSCs in accordance with recent regulatory changes. The decision does not modify existing safety regulations.

ESTIMATED COST:

- None anticipated.

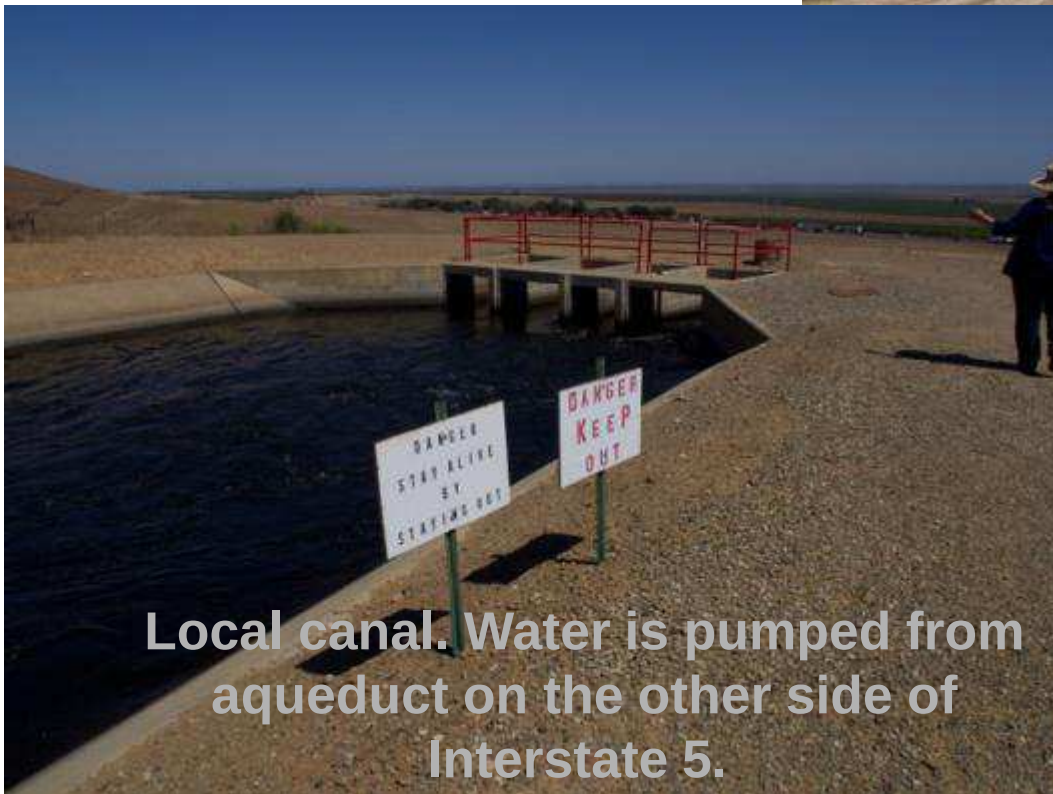

California Public Utilities Commission Highway-rail Crossing Improvement Programs

Section 190 and 130 Overview

May 2015





Background

The Section 190 program provides State funding to public agencies to grade-separate highway-rail crossings. The funds are allocated based on a prioritized list of projects established by the Public Utilities Commission. The State allocates \$15 million a year to public agencies.

The Section 130 program provides Federal funding to railroads and local agencies to improve existing at-grade highway-rail crossings. New projects are identified and prioritized annually by Commission staff.





Selection Process

Factors considered for selecting crossings

- Vehicular and train volumes
- Project Costs
- Accident History
- Sightlines along the crossing approaches
- Geometry (crossing angle)

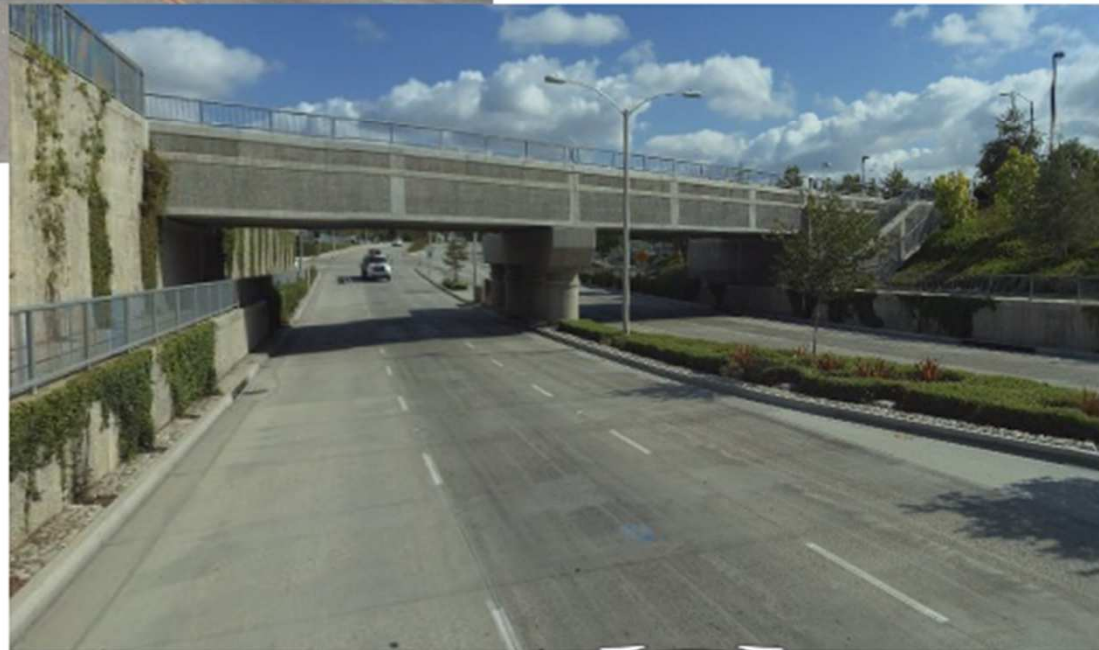




Section 190 Project - Brea Canyon Road, City of Industry Grade-Separation

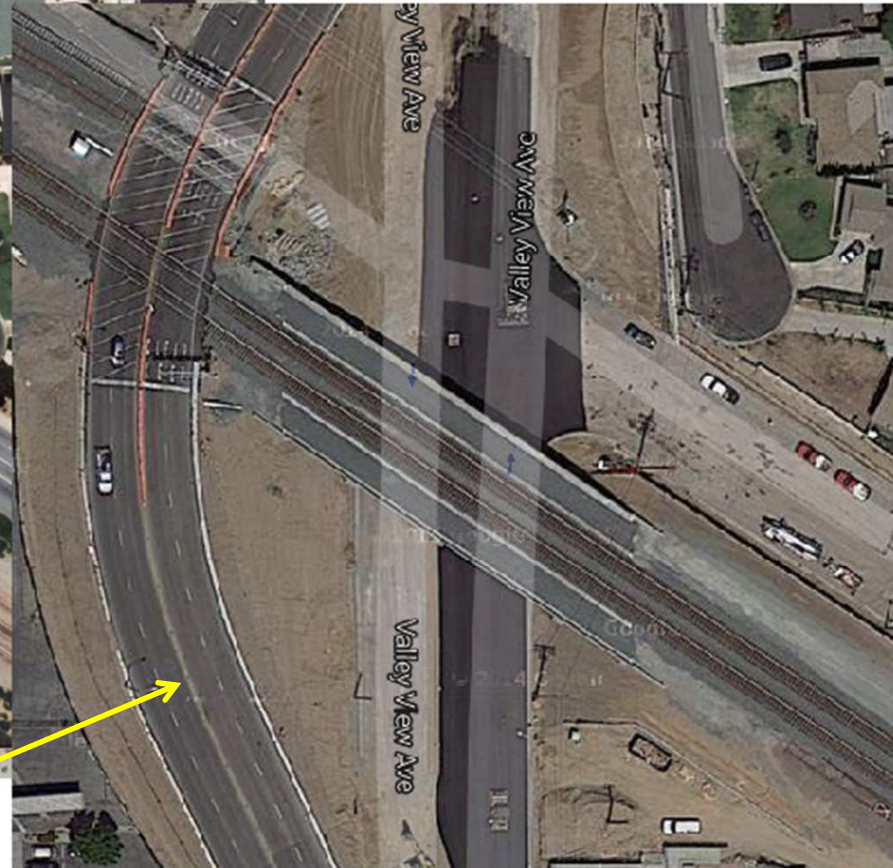
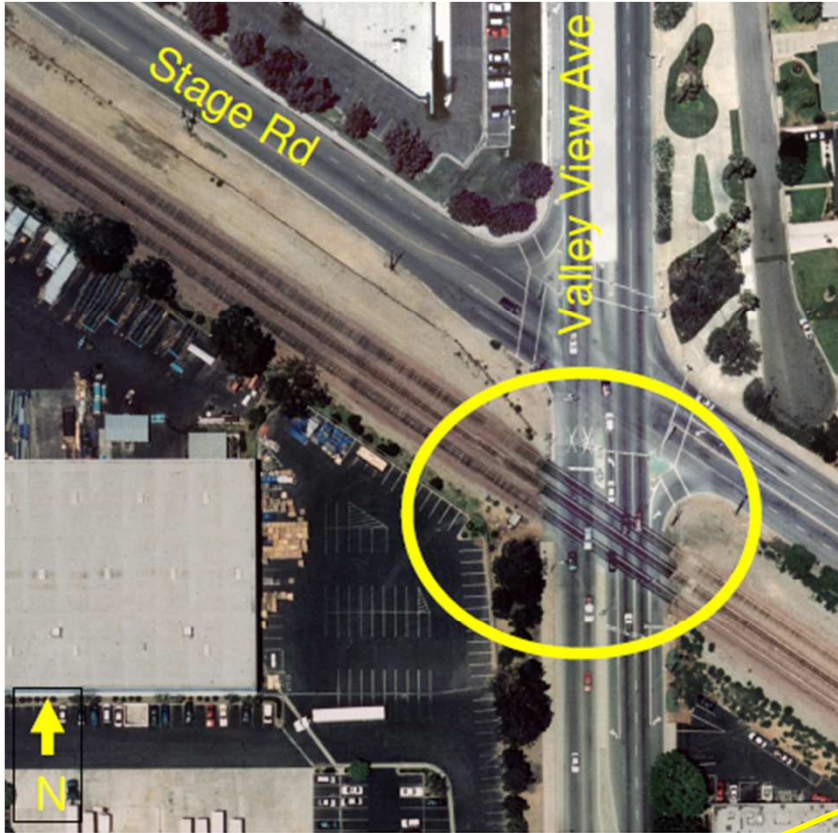

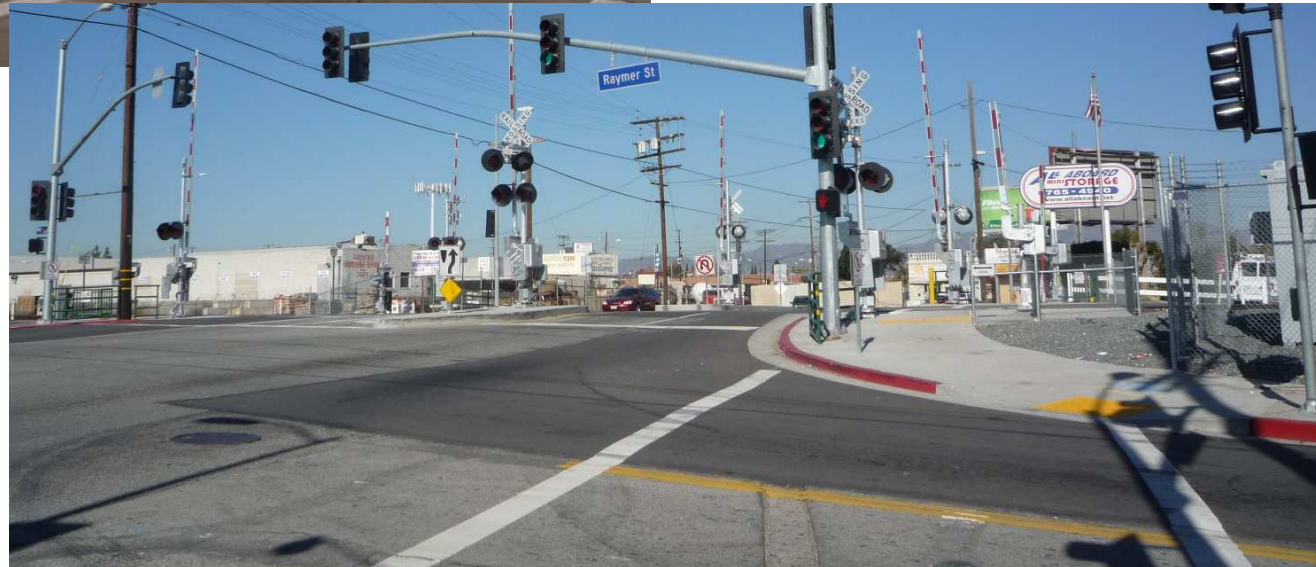

 - o 3 Data Analysts & 3 vacancies

Through CAB, the Commission continues to perform an informal consumer assistance function that has been its history for over 90 years.





CAB's Mission

Assist consumers by answering questions and helping to resolve complaints on billing, service quality, disconnects, payment plans and LifeLine.

- Act as a neutral facilitator for consumer informal complaints with regulated energy, water and telecommunications utilities.
- Refer consumers to appropriate resources in cases where the utility/issue is not regulated by the CPUC or they have called the CPUC by mistake.
- Offers a way to resolve issues quickly without the organizational expense of a formal complaint.

- CAB is able to serve consumers in various languages, including Spanish, Chinese and Tagalog. We also have access to the Language Assistance Line that provides real-time translation to assist limited-English speaking consumers in up to 170 languages.
- CAB is almost entirely paperless:
 - The Consumer Information Management System (CIMS) database captures informal contact details including incoming and outgoing correspondence.
