

- Proposes modifications to settlement on rate designs for PG&E's largest nonresidential customers.

#### **Presentation Overview**

- Pre-2018 situation
  - High profile crash spurred greater coordination between TEB and Wine Country law enforcement against unlicensed passenger carriers
- Early training efforts
  - Coordination with and education of local law enforcement officers starts in Napa County
- 2018 enforcement activity
  - Joint operations produce positive results and discourage illegal operations
- Future trainings
  - Plans to expand operations across Napa County and into Sonoma County

### **Pre-2018 Situation**

#### **Enforcement Prior to 2018**

- Investigators would follow up on leads of illegal activity, write up investigation reports, and issue administrative citations
- Illegal advertising (PU Code § 5414.5)
- Illegal operations (PU Code § 5411)
  - Three elements need to prove illegal transportation
    - Proof of passengers
    - Proof of compensation
    - Proof that the trip was over public highways
- October 8, 2017 unpermitted bus crash with Wine Train was impetus for greater enforcement against illegal carriers

# **Early Training Efforts**

### Law Enforcement Training Yountville, CA (Napa County)

#### January 30, 2018:

- TEB staff provided training on CPUC regulations
- Attendees:
  - Napa Valley Railroad Police
  - Napa Police Department
  - American Canyon Police Department
  - Napa County Sheriff's Department

### Law Enforcement Training Yountville, CA (Napa County)

Law Enforcement agencies identified two major areas of interest:

- TNCs and how to retrieve waybills on electronic devices
   Waybills are proof that the transportation was prearranged and
   show that the ride was prearranged. Lack of a waybill means that
   the driver is acting independently/illegally and the ride is not
   covered by the TNC's insurance
- Procedures to impound vehicles
   Impounds are an effective way to combat illegal carriers.
   Procedures are outlined under Public Utilities Code § 5387(d)

# Impounding per Public Utilities Code § 5387(d)

Any peace officer may impound a bus or limousine of a charter-party carrier if the peace officer determines:

- The driver operated the vehicle while the carrier lacked a valid permit or certificate
- The driver operated the vehicle after the CPUC suspended the carrier's permit or certificate
- The driver was driving without a current and valid driver's license, a passenger endorsement, or a valid certificate

### **2018 Enforcement Activity**

# First Napa County Interagency Operation: February 2, 2018

- The team found two carriers operating after revocation of their permits, and impounded their vehicles
- One driver lacked the type of commercial driver's license needed to operate a bus and was cited for driving out of class
- One carrier operated without workers' compensation insurance; the case was referred to the Napa County District Attorney's office for prosecution
- Agencies agreed to continue coordinated enforcement efforts moving forward.

# Napa County Interagency Operations: Common Violations

- Reasons for impoundment and citation include:
  - Carrier operated after its permit expired and the CPUC denied its renewal application
  - Carrier operated without obtaining a permit
  - Carrier operated with a pending permit
  - Driver was operating without the proper license
