Item #5 [22558] – California Advanced Services Fund for The Broadband Infrastructure Grant Account Application of Surfnet Communications, Inc.

Res T-17821

PROPOSED OUTCOME:

- Deploys last-mile broadband infrastructure to enable Fiber-to-the-Premises (FTTP) broadband service at speeds of up to 1 gigabit per second (Gbps) download and 1 Gbps upload to 465 California Advanced Services Fund (CASF) eligible locations in San Luis Obispo, Santa Clara and Santa Cruz counties.

SAFETY CONSIDERATIONS:

- The CASF program encourages deployment of broadband throughout the State to enable the public to access Internet-based safety applications, telehealth services, emergency services, and to allow first responders to communicate with each other and collaborate during emergencies.

ESTIMATED COST:

- \$10,083,005.

Item #6 [22563] – California Advanced Services Fund Adoption Account

Res T-17819

PROPOSED OUTCOME:

- Approves two project proposals for \$320,126 and conditional approval of one project proposal for \$1,001,697 and denies one proposal from the California Advanced Services Fund Broadband Adoption Account submitted in the January 2024 application round.

SAFETY CONSIDERATIONS:

- There are no safety considerations associated with this resolution.

ESTIMATED COST:

- \$1,321,823.

Item #9 [22572] – Fiscal Year 2024-25 Budget Allocations for California Advanced Services Fund

Res T-17825

PROPOSED OUTCOME:

- Approves the fiscal year 2024-25 budget of \$136,211,000.
- Allocates funds for six California Advanced Services Fund accounts, including the Broadband Adoption Account, Rural and Urban Regional Broadband Consortia Grant Account, Infrastructure Line Extension Pilot Program, Broadband Infrastructure Grant Account, Broadband Public Housing Account, and Tribal Technical Assistance Program.

SAFETY CONSIDERATIONS:

- There are no safety considerations associated with this resolution.

ESTIMATED COST:

- \$136,211,000.

Item #10 [22575] – California Advanced Services Fund Rural Fresno Project

Res T-17823

PROPOSED OUTCOME:

- Approves funding for the grant application of CalNeva Broadband, LLC for its Rural Fresno Project which consists of a last-mile broadband network with a combination of hybrid fiber-coax technology that will enable speeds of up to 1 gigabit per second download and 30 megabits per second (Mbps) upload to 500 unserved locations and fixed wireless access technology that will enable speeds of up to 500 Mbps symmetrical to 100 unserved locations in Fresno County.

SAFETY CONSIDERATIONS:

- The California Advanced Services Fund program encourages the deployment of broadband throughout the State to enable the public to access Internet-based safety applications, telehealth services, emergency services, and to allow first responders to communicate and collaborate during emergencies.

ESTIMATED COST:

- \$519,260.

Item #11 [22578] – Public Housing Infrastructure Projects for Grant Funding from the California Advanced Services Fund

Res T-17824

PROPOSED OUTCOME:

- Approves six (6) public housing infrastructure projects for grant funding from the California Advanced Services Fund's Broadband Public Housing Account totalling \$596,315.97.

SAFETY CONSIDERATIONS:

- The installed networks will provide free broadband service to 346 units in low-income housing. These projects will deploy broadband network infrastructure to publicly supported housing developments capable of 25 Mbps download and 3 Mbps upload speeds.

ESTIMATED COST:

- \$596,315.97.

Item #12 [22579] – California Advanced Services Fund for the Broadband Infrastructure Grant Account Application of LCB Communications LLC

Res T-17817

PROPOSED OUTCOME:

- Deploys a hybrid (middle-mile and last-mile) network combining Fiber-to-the-Home (FTTH) and Fixed Wireless Access (FWA) at speeds of up to 5 gigabits per second symmetrical FTTH and 600 megabits per second (Mbps) download/100 Mbps upload FWA to 1,101 locations in San Benito, Santa Cruz, and Monterey Counties.

SAFETY CONSIDERATIONS:

- This project will serve communities identified by the CPUC as Tier 2 - "Elevated Fire-Threat Zones." The network will provide access to Internet-based safety applications, telehealth services, emergency services and access to communications during natural or man-made emergencies.

ESTIMATED COST:

- \$29,482,765.91 funding for the project from the California Advanced Services Fund.

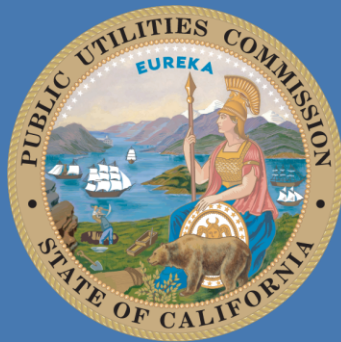
